## **NOTICE TO ALL HORTICULTURE TRADERS**

### **CLOSE AND OPEN BORDER FOR SPECIAL CONTROLLED PRODUCTS**

**SPECIAL IMPORT PERMIT PERIOD: 01 – 30 November 2020**

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro rata imports will be implemented for the following special controlled products:

PRODUCT	DESCRIPTIONS	CLOSED	OPEN	PRO RATA
Beetroot	<b>Border closed</b> for importation of fresh, chilled, Whole or Cut Red Beetroot. <b>No import restriction on large size Beetroot.</b>			
Butternut	<b>30%</b> importation of fresh, chilled, Whole or Cut butternut.			
Cabbage	<b>Border closed</b> for importation of fresh, chilled, Whole or Cut Green Head Cabbage.			
Carrot	<b>Border closed</b> for importation of fresh, chilled, Whole or Cut Orange Carrot. Except exclusions.			
English Cucumber	<b>50%</b> importation of all fresh, chilled, Whole or Cut English Cucumber.			
Green Pepper	Open for importation without restriction but the 47% MSP applies.			
Gem Squash	<b>Border closed</b> for importation of fresh, chilled, whole and cut Germ Squash. Except exclusions.			
Onion	<b>Border closed</b> for importation of fresh, chilled, whole or cut normal white or brown onions. Except exclusions.			
Potato Washed	Open for importation without restriction but the 47% MSP applies.			
Pumpkin	Open for importation without restriction but the 47% MSP applies.			
Sweet Potato	<b>30%</b> importation of fresh, chilled, Whole or Cut Sweet Potato. Except exclusions.			
Sweet Melon	<b>Border closed</b> for importation of fresh, chilled, whole or cut sweet melon. Except exclusions.			
Round/Jam Tomato	<b>30%</b> for importation of fresh, chilled, Whole or Cut Red Round/ Jam.			
Watermelon	<b>Border closed</b> for importation of fresh, chilled, whole or cut watermelon.
