NOTICE TO ALL HORTICULTURE TRADERS

CLOSE AND OPEN BORDER FOR SPECIAL CONTROLLED PRODUCTS

SPECIAL IMPORT PERMIT PERIOD: 01 – 31 January 2021

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro rata imports will be implemented for the following special controlled products:

PRODUCT	DESCRIPTIONS	CLOSED	OPEN	PRO RATA
Beetroot	Border closed for importation of fresh, chilled, Whole or Cut Red Beetroot, including large size beetroots/catering size.			
Butternut	Border closed for importation of fresh, chilled, Whole or Cut butternut.			
Cabbage	Border closed for importation of fresh, chilled, Whole or Cut Green Head Cabbage.			
Carrot	Border closed for importation of fresh, chilled, Whole or Cut Orange Carrot. Except exclusions.			
English Cucumber	Border closed importation of all fresh, chilled, Whole or Cut English Cucumber.			
Green Pepper	Border closed importation of fresh, chilled, Whole or Cut Green pepper. Except exclusions.			
Gem Squash	Open for importation without restriction but the 47% MSP applies.			
Onion	Open for importation without restriction but the 47% MSP applies.			
Potato Washed	Open for importation without restriction but the 47% MSP applies.			
Pumpkin	Border closed for importation of fresh, chilled, whole or cut white or grey/blue pumpkins. Except decorative pumpkins.			
Sweet Potato	30% importation of fresh, chilled, Whole or Cut Sweet Potato. Except exclusions.			
Sweet Melon	50% for importation of fresh, chilled, whole or cut sweet melon. Except exclusions.			
Round/Jam Tomato	30% for importation of fresh, chilled, Whole or Cut Red jam.			
Watermelon	50% for importation of fresh, chilled, whole or cut watermelon.
