NOTICE TO ALL HORTICULTURE TRADERS

CLOSE AND OPEN BORDER FOR SPECIAL CONTROLLED PRODUCTS

SPECIAL IMPORT PERMIT PERIOD: 01 – 30 June 2021

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro rata imports will be implemented for the following special controlled products:

PRODUCT	DESCRIPTIONS	CLOSED	OPEN	PRO RATA
Beetroot	Border closed importation of fresh, chilled, Whole or Cut beetroot. Except exclusions.			
Butternut	Border closed for importation of fresh, chilled, Whole or Cut butternut. Except exclusions.			
Cabbage	Border closed for importation of fresh, chilled, Whole or Cut Green Head Cabbage for the first two weeks.			
Carrot	50% importation of fresh, chilled, Whole or Cut Carrots. Except exclusions			
English Cucumber	Border closed for importation of all fresh, chilled, Whole or Cut English Cucumber. Except exclusions.			
Green Pepper	Border closed for importation of fresh, chilled, Whole or Cut Green pepper. Except exclusions.			
Colored pepper	Border closed for importation of fresh, chilled, whole and cut red and robot peppers. Except exclusions and loose sell / single line yellow peppers.			
Gem Squash	Open for importation without restriction but the 47% MSP applies.			
Onion	Border closed for importation of fresh, chilled, Whole or Cut white onions. Except exclusions.			
Potato Washed	Open for importation without restriction but the 47% MSP applies.			
Pumpkin	Border closed importation of fresh, chilled, whole or cut white or grey/blue pumpkins. Except decorative pumpkins.			
Sweet Potato	Border closed for importation of fresh, chilled, Whole or Cut Sweet Potato. Except exclusions and Orange sweet potatoes.			
Sweet Melon	Open for importation without restriction but the 47% MSP applies.			
Round Tomato	Border closed importation of fresh, chilled, whole or cut tomatoes round.			
Jam Tomato	Border closed importation of fresh, chilled, whole or cut tomatoes jam.			
Watermelon	50% importation of fresh, chilled, Whole or Cut watermelon. Except exclusions			
Sweetcorn	Open for importation without restriction but the 47% MSP applies.			
Lettuce (iceberg)	30% importation of fresh, chilled, whole or cut light green/green iceberg lettuce. Except exclusions.
