### CLOSE AND OPEN BORDER FOR SPECIAL CONTROLLED PRODUCTS

**SPECIAL IMPORT PERMIT PERIOD: 01 – 31 March 2022**

**Revision date: 03 March 2022**

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro-rata imports will be implemented for the following special controlled products:

PRODUCT	DESCRIPTIONS	CLOSED	OPEN	PRO RATA
Beetroot	50% importation of all types, size groups and container sizes fresh, chilled, Whole or Cut beetroots. Except the "Exclusions".			
Butternut	<b>Border closed</b> for importation of all types, size groups and container sizes fresh, chilled, Whole or Cut butternut. Except the "Exclusions"			
Cabbage	30% importation of all types, size groups and container sizes fresh, chilled, Whole or Cut Green Head Cabbage. Except the "Exclusions".			
Carrot	50% importation of all types, size groups and container sizes fresh, chilled, Whole or Cut carrots.			
English Cucumber	<b>Border closed</b> for importation of all types, size groups and container sizes fresh, chilled, Whole or Cut English Cucumber.			
Green Pepper	<b>Border closed</b> for importation of all types, size groups and container sizes fresh, chilled, Whole or Cut green peppers. Except the "Exclusions".			
Colored pepper	<b>Border closed</b> for the importation of all types, size groups and container sizes fresh, chilled, Whole or Cut coloured peppers. Except the "Exclusions".			
Gem Squash	<b>Open</b> for importation without restriction but the 47% MSP applies.			
Onion	<b>Open</b> for importation without restriction but the 47% MSP applies.			
Potato Washed	<b>Open</b> for importation without restriction but the 47% MSP applies.			
Pumpkin	<b>Border closed</b> for the importation of all types, size groups, and container sizes fresh, chilled, Whole or Cut Pumpkin. Except the "Exclusions".			
Sweet Potato	<b>Border closed</b> for importation of all types, size groups, and container sizes fresh, chilled, Whole, or Cut sweet Potato in the <b>first two weeks only from 1-15.03.22</b> . Except <b>Orange sweet potatoes</b> and exclusions.			
Round/Jam tomato	30% importation of all types, size groups and container sizes are fresh, chilled, Whole, or Cut tomato round/jam. Except for the "Exclusions"			
Watermelon	<b>Open</b> for importation without restriction but the 47% MSP applies.			
Sweet Melon	<b>Open</b> for importation without restriction but the 47% MSP applies.			
Sweetcorn	30% importation of all types, size groups, and container sizes fresh, chilled, Whole or Cut sweetcorn. Except the "Exclusions".			
Lettuce (iceberg)	30% importation of all types, size groups, and container sizes fresh, chilled, Whole or Cut sweetcorn. Except the "Exclusions".			
Spinach	<b>Open</b> importation of all types, size groups, and container sizes fresh, chilled, Whole, or Sliced spinach. Except the "Exclusions".
