
Dear Producers and Millers

**SUBJECT: WHITE MAIZE GRAIN FLOOR PRICE – 24 JULY -06 AUGUST 2022**

1. In terms of the 2021 white maize marketing agreement under section 2.2, Should the calculated SAFEX Spot Price- Weighted Average for the previous fortnight period be higher than the Staggered Floor Price, then the SAFEX- Fortnight Weighted Average Price formula shall be implemented.
2. As per the attached calculation, the **FINAL SAFEX- Fortnight Weighted Average Price** for the previous two weeks (08 to 21 July 2022) of **N\$6,364.57 per ton** is higher than the **Staggered Floor Price** of **N\$4,875 per ton** for the period 24 July to 06 August 2022 by **N\$1,489.90 per ton**.
3. Therefore, the **SAFEX- Fortnight Weighted Average Price** of **N\$6,364.57 per ton** will be the **Floor Price** applicable for WM1 to be bought or delivered within the fortnight of **24 July - 06 August 2022**.
4. The NAB will continue monitoring the SAFEX- Fortnight Weighted Average Price for the upcoming two weeks and notify the industry accordingly, should this price be higher than the Staggered Floor Price for the same period.
5. Furthermore, please take note that, both the producer levy of 1.4% should be calculated on the Subtotal SAFEX- Fortnight Weighted Average Price of **N\$6,143.41** which is equivalent to **N\$86.00** per ton.
6. Please take note that this floor price is subject to changes every fortnight and hence not fixed for the entire marketing season.



**Dear Producers and Millers**

**SUBJECT: ZAMBEZI REGION - WHITE MAIZE GRAIN POOL FLOOR PRICE FOR THE PERIOD 24 JULY TO 06 AUGUST 2022**

1. Section 2.4 of the white maize grain marketing agreement for the 2022 season and the modalities regarding the marketing of white maize grain from the Zambezi region mandates the NAB to set a pool floor price.
2. Therefore, as per the attached calculation for the **Pool Floor Price for the white maize grain to be marketed by farmers from the Zambezi region during the period 24 July to 06 August 2022 shall not be less than N\$5,725.20, per ton (N\$286.26 per 50kg bag)** at mill door, calculated based on the **SAFEX- Fortnight Weighted Average Price of N\$6,364.57 per ton**, less **N\$553.37** deducted for the pool transport cost and handling fee, as well as the NAB statutory producer levy of 1.4% (**N\$86.00 per ton**).
3. The Pool Floor Price (mill door) shall be paid by all millers buying white maize grain from farmers in the Zambezi region, irrespective of whether the maize is delivered to millers in or outside the Zambezi region, and a farm gate price shall not be applicable.
4. The pool transport cost, handling fee, and the producer levy shall be deducted from the SAFEX - Fortnight Weighted Average Price of **N\$6,364.57 per ton** and shall be paid over to the NAB by the miller buying the maize from the farmer.
5. On a monthly basis, the NAB will reimburse the participating millers who are outside the Zambezi region for the transport costs and AMTA for the handling costs out of the pool funds, based on the total tonnage and the actual transport and handling costs.
6. The reimbursement of transport costs to millers who are outside the Zambezi region will be limited to the rates for each town/ city, as follows:



7. Furthermore, in cases where white maize grain is delivered in bags, the farmer must be reimbursed for the cost of the bags at 40% of the price of the new bag.
8. Please take note that the white maize grain Pool Floor Price for the Zambezi region is subject to changes every fortnight and hence not fixed for the entire marketing season.
