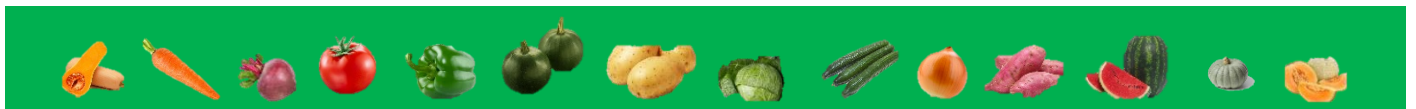

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro-rata imports will be implemented for the following special controlled products:

Cabbage	<b>Border closed</b> for the importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Cabbage. Except for the "Exclusions			
Carrot	30% importation of all types, size groups, and container sizes fresh, chilled, Whole, or Cut Carrot. Except for the "Exclusions			
English Cucumber	40% importation of all types, size groups, and container sizes fresh, chilled, Whole or Cut English cucumber. Except for the "Exclusions.			
Colored Pepper	40% importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut colored peppers. Except for the "Exclusions.



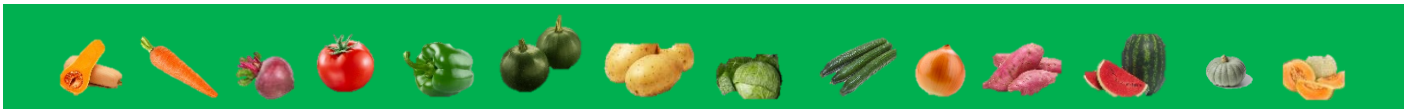
