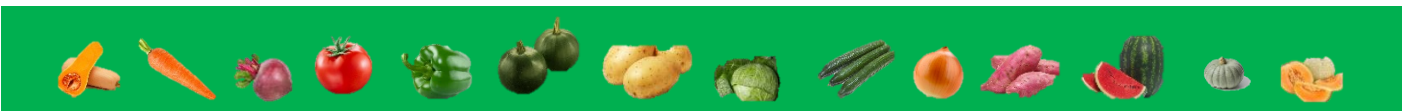

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro-rata imports will be implemented for the following special controlled products:

Carrot	Open for importation without restriction but the 47% MSP applies			
English Cucumber	Border closed for importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut English Cucumber. Except for the "Exclusions..			
Colored Pepper	Border closed importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Coloured Pepper. Except for the "Exclusions.			
Green pepper	Border closed for the importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Green Pepper. Except for the "Exclusions.			
Gem Squash	Open for importation without restriction but the 47% MSP applies


