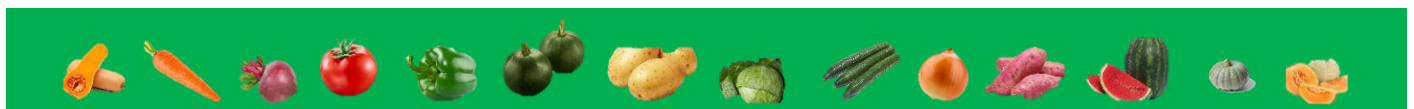

SPECIAL IMPORT PERMIT PERIOD: 01 – 30 May 2025

In line with the Agronomic Industry Act (Act 20 of 1992), and the Namibian Horticulture Market Share Promotion Scheme rules and regulations, close border and pro-rata imports will be implemented for the following special controlled products:

Beetroot	Open for importation without restriction but the 47% MSP applies.			
Butternut	Border closed for importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut butternuts. Except for the "Exclusions			
Cabbage	Border closed for importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut green cabbages. Except for the "Exclusions			
Carrot	Open for importation without restriction but the 47% MSP applies.			
English Cucumber	Border closed for importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut English Cucumber..Except for the "Exclusions			
Colored Pepper	Border closed importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Coloured peppers.. Except for the Red pepper open on 30% importation.			
Green pepper	Border closed for importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Green peppers..Except for the "Exclusions			
Gem Squash	50% importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Germ squash. Except for the "Exclusions.			
Onion	50% importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Onions.Except for the "Exclusions. Until 16th May 2025 only.			
Potato Washed	Open for importation without restriction but the 47% MSP applies.			
Pumpkin	50% importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Pumpkins.Except for the "Exclusions, decorative pumpkin & hubbard squash.			
Sweet Potato	Border Closed for importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut beetroot. Except for the "Exclusions			
Jam tomato	30% importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Jam tomato. Except for the "Exclusions			
Cocktail tomato	20% for the importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut cocktail tomato.Except for the "Exclusions			
Round tomato	Border Closed importation of all types, size groups, and container sizes of fresh, chilled, Whole, or Cut Round tomato. Except for the "Exclusions			
Watermelon	Open for importation without restriction but the 47% MSP applies			
Sweet Melon	Open for importation without restriction but the 47% MSP applies			
Sweetcorn	Open for importation without restriction but the 47% MSP applies.			
Lettuce (iceberg)	Open for importation without restriction but the 47% MSP applies.
