ALL MAHANGU GRAIN PRODUCERS AND PROCESSORS IN NAMIBIA

RE: PEARL MILLET (MAHANGU) GRAIN: FLOOR (MINIMUM) PRICE FOR THE 2025 MARKETING SEASON.

In line with the Agronomic Industry Act, 20 of 1992 and the mahangu marketing agreement for the 2025 season between organised producers and processors, the Namibian Agronomic Board (NAB) calculates the floor (minimum) price for mahangu grain annually, based on the cost of inputs for commercial production for the 2024/2025 planting season.

This formula has been agreed upon by the organised mahangu grain producers and processors and endorsed by the NAB Board to safeguard an orderly marketing environment and to stimulate local production and marketing of surplus mahangu grain in Namibia.

Therefore, the NAB hereby announces the mahangu grain floor price for the 2025 marketing season, that commenced on 01 June 2025.

The **Floor (Minimum) Prices** per ton to be paid by millers for **grade 1 mahangu grain**, for the **2025 marketing season** shall be as follows:

MILL-DOOR FLOOR PRICE	N\$7,202.75	N\$7.20	N\$360.14
FARM GATE/ COLLECTION CENTER FLOOR PRICE	N\$6,910.31	N\$6.91	N\$345.52

PLEASE TAKE NOTE OF THE FOLLOWING:

- The Producer levy of 1.4% (N\$100.84 per ton) is already deducted from the **Mill-Door Floor Price** given above. Millers will be invoiced by the NAB for the producer levy of N\$100.84 per ton collected, based on the actual tonnage purchased.
- The Producer levy of 1.4% (N\$100.84 per ton) and the producer's transport cost share of N\$292.44 per ton is already deducted from the **Farm Gate/ Collection Floor Price** given above. Millers will be invoiced by the NAB for the Producer levy of N\$100.84 per ton collected, based on the actual tonnage purchased, and the miller cannot make any **further transport deductions** from the Farm Gate/ Collection Center Floor Price.


